10. Wolf River Fire Dept. N4445 Hwy 55, White Lake WI 54491
Covers the Town of Wolf River except the following:

Section 20, T31N-R15E is covered by the Doty Fire Dept. from Oconto County

Sections 1,2,3,4,5,6,8,9,10,11 & 12 T33N-R14E in northeast Wolf River are covered by Wabeno Fire Control

The area around Lake Mary (Sec 36 T33N-R14E and Sec. 1 T32N-R13E is covered by the Townsend Fire Dept..

They cover the portion of Sections 15,22,27 & 35 of T31N R14E that are on the east side of the Wolf River. The White Lake FD covers the rest as listed above.
