

**Town of Antigo
Town Board Meeting
May 18, 2010**

Chairperson Rick Parilek called the Monthly Board Meeting to order on May 18, 2010 at 7:30 p.m. at the Antigo Town Hall. Other Board members present were Supervisor Jon Petroskey, Supervisor Wayne Schroeder, Clerk Rosemary Servi and Treasurer Cindy Igl.

The clerk read the minutes of the prior month's meeting. Wayne stated that since the last meeting, Pat Frey and Jim Schofield of Pete's Distributing LLC, has decided not to purchase the property at W9579 Forrest Road for their business. The minutes were approved with a motion by Jon and second by Wayne. Motion carried.

Tony Letter from Northeast Asphalt, Inc. and Ray Gausmann from American Asphalt of WI were present. The Board opened bids for blacktopping Parkway Road from County Highway F north to Flight Road for approximately one-half mile. The bids were: American Asphalt of WI at \$57.17 per ton with 709 tons for a total of \$40,533.53; Pitlik & Wick, Inc. at \$57.90 per ton with 690 tons for a total of \$39,951; and Northeast Asphalt Inc. for \$51.60 per ton with 723 tons for a total of \$37,306.80. The Board then opened bids for pulverizing and reshaping Parkway Road from County Highway F north to Flight Road for approximately one-half mile. The bids were: American Asphalt of WI at \$5,272; Pitlik & Wick, Inc. at \$4,472.50; and Northeast Asphalt, Inc. at \$3,050. Rick motioned to go with Northeast Asphalt, Inc. bids of \$37,306.80 for blacktopping Parkway Road and \$3,050 for pulverizing and reshaping Parkway Road. Jon seconded. Motion carried.

Wayne motioned to approve alcohol beverage licenses contingent upon no problems for Rick's 45 Roadhouse LLC and CA Northside LLC for the period 7/1/10 to 6/30/11. Jon seconded. Motion carried.

A motion was made by Wayne to appoint Cindy Igl, Pete Pennington and Wayne Dieck as alternates for the Board of Review. Jon seconded. Motion carried.

The treasurer's report showed a checking balance of \$6,720.40, savings balance of \$349,422.79 and tax account balance of \$10.00 for a total of \$356,153.19.

The Board of Review will be held on Thursday, June 3rd from 7 p.m. to 9 p.m. Gene Matuszewski will have his open book on Thursday, May 27th from 9 a.m. to 11 a.m.

Our next Board Meeting will be held on Wednesday, June 9th at 7:30 p.m.

All approved bills were paid.

A motion was made to adjourn by Wayne at 9:20 p.m. Jon seconded. Motion carried.
