

**Town of Antigo
Town Board Meeting
April 14, 2009**

Chairperson Rick Parilek called the Monthly Board Meeting to order on April 14, 2009 at 7:30 p.m. at the Antigo Town Hall. Other Board members present were Supervisor Jon Petroskey, Supervisor Wayne Schroeder, Clerk Rosemary Servi and Treasurer Cindy Igl.

The clerk read the minutes of the prior month's meeting. The minutes were approved with a motion by Wayne and second by Jon. Motion carried.

Oath of Office forms were completed by all elected officials.

Carol McDougal was present regarding her and Bruce McDougal's waiver request to minor subdivision. Carol had a new certified survey map which showed the easement and that both back lots were over 3 acres. Rick motioned to approve the request based on the new certified survey map submitted to the town board on April 14, 2009. Jon seconded. Motion carried.

Tim Grall from the Antigo Sno-Drifters was present regarding their new tractor purchase. As they have done in the past, they would like to use the town's name in order to save \$10,000. The Antigo Sno-Drifters paid the legal fee to have our Attorney, Jerry McCormack, draft a Lease Guaranty and Agreement. Jon motioned to approve the request and sign the Lease Guaranty and Agreement. Wayne seconded. Motion carried.

Bids were opened for adding three-inch gravel lift, pulverizing and reshaping of Crestwood Road from Forrest Road south to the town line. Bids received were: Musson Brothers, Inc. for pulverizing & reshaping for \$3,780 and gravel supplied by Krueger & Steinfest for \$4,944 for a total bid of \$8,724; American Asphalt of Wisconsin for gravel, pulverizing and reshaping for \$7,392 with the gravel being supplied by Krueger & Steinfest; Northeast Asphalt, Inc. for gravel, pulverizing and reshaping for \$9,802; and an estimate from the Langlade County Highway Department for gravel only for \$3,758. Rick motioned to go with American Asphalt for \$7,392 with the work done the first part of July. Wayne seconded. Motion carried.

Bids were opened for blacktopping Crestwood Road from Forrest Road south to the town line. This is a TRIP project. Bids received were: an estimate from the Langlade County Highway Department for \$33,467; American Asphalt of Wisconsin for \$38,814.60; and Northeast Asphalt, Inc. for \$33,572.62. Paul Bentley, from Northeast Asphalt was present and stated that they would do brushing up before paving. Jon motioned to go with Northeast Asphalt for \$33,572.62 with the work done the first part of August. Rick seconded. Motion carried.

Jon motioned to appoint Leah Igl as fire department executive secretary for the period 4/15/2009 to 4/14/2010. The rate of pay will be \$7.25 per hour and continue with a maximum of 25 hours per month. Wayne seconded. Motion carried.

The treasurer's report showed a checking balance of \$7,146.80, savings balance of \$155,483.96 and tax account balance of \$134,266.69 for a total of \$296,897.45.

The Annual Town Meeting will be held on Thursday, April 16th at 7:30 p.m.

Our next Board Meeting will be held on Wednesday, May 13th at 7:30 p.m.

The Board of Review will be held on Wednesday, June 3rd from 7 p.m. to 9 p.m.

All bills approved were paid.

A motion was made to adjourn by Wayne at 9:45 p.m. Jon seconded. Motion carried.
