**Property Taxes:** Preferred they be mailed to W6904 Hwy 47, Antigo, WI 54409 and made payable to “Town of Norwood Treasurer”. If you require a receipt please send a self addressed postage paid envelope and a receipt will be sent back to you immediately. I will also hold office hours at my home for those of you who prefer to pay in person from **4p-6p** on:

January 26, 27, 31 2011**

Remember if you mail in your payment it will be accepted as long as it is postmarked December 31, 2010 or January 31, 2011.

**Dog License:** Please send proof of your pets rabies vaccination from your veterinarian, your certificate will be returned to you along with the license. If you no longer have a dog please let me know so I can update my records. The cost for a license is \$3.00 each for spayed or neutered and \$8.00 each for dogs that are NOT spayed or neutered.

**Pet Clinic:** The pet clinic will be held on Saturday January 15, 2011 from 10 a.m. – 11:30 a.m. at the Town Hall for anyone who needs to have their pet(s) vaccinations updated. The Birnamwood Vet Clinic will have their pricing available. Dog licenses will also be available, no taxes will be collected during this time.
