5. That, upon information and belief, the subject **is/is not** indigent.

6. That attached hereto and made a part hereof are Affidavits by each petitioner which aver with particularity the factual basis for the allegations contained in this Petition.

**WHEREFORE**, we, the undersigned petitioners, request that the subject be placed under an involuntary alcohol commitment to the custody of the Langlade County 51.42 Community Services Board, or for such other relief as the Court may deem necessary.
