



2022 Langlade County Forestry, Parks and Recreation Department Fee Schedule

Facilities and Grounds Commercial/Non-Commercial Rates

Any individual or organization requesting use of county facilities will be classified by the Department as **Non-commercial**, **Commercial**, or **Exempt** user.

Non-Commercial Activities include but are not limited to:

- a.) Events charging spectator admission, entry fees, participation fees, gate fees, or is soliciting donations when all proceeds from admissions, fees or donations are received and utilized by the Langlade County based Civic Group or other non-profit group for projects or programs for betterment of Langlade County facilities or citizens.
- b.) Events with for-profit sales of products or services, when all proceeds from sales are received and utilized by the Langlade County based Civic Group or other non-profit group for projects or programs for betterment of Langlade County facilities or citizens.
- c.) Events conducted for the promotion of commercial products and/or services when all income from promotions is received and utilized by the Langlade County based Civic Group or other non-profit group for projects or programs for betterment of Langlade County facilities or citizens.

Examples of some events qualifying for Non-commercial rates include:

- a.) Events where a facility is rented by a single individual for the purpose of gathering a privately invited group of people to celebrate. (Birthday party, memorial service, graduation party, wedding, family reunion, etc.).
- b.) Events open to the public such as fundraisers or athletic events with registration organized by any private businesses, individuals, civic groups or non-profit organizations from outside of Langlade County who prove their events sole objective is contributing to the betterment of Langlade County facilities or citizens.
- c.) Non-profit organizations based in Langlade County utilizing a facility for a non-commercial activity such a meeting, or a private party.

A Non-Commercial User rate may be applied for events considered to be a commercial activity if the event is conducted by a Langlade County based Civic Group (proof of State of Wisconsin Tax Exemption Certification may be required) which can prove the events sole objective is contributing to the betterment of Langlade County facilities or citizens.

For events conducted by other non-profit entities outside Langlade County (proof of State of Wisconsin Tax Exemption Certification is required) or For-Profit organizations that are considered to be planning a commercial activity, a Non-Commercial rate may be applied if a substantial amount of funds generated by the proposed event are put towards the betterment of Langlade County facilities or citizens.

Commercial user rates shall be applicable for events held at licensed facilities when any individual, business, commercial enterprise, service, youth, church, or non-profit entity result in commercial monetary gain or commercial benefits, regardless of the disbursement of the proceeds. These commercial rates will be charged for all days that the facilities are occupied.

Commercial Activities include but are not limited to:

- a.) Events charging spectator admission, entry fees, participation fees, gate fees, or is soliciting donations.
- b.) Events with for-profit sales of products or services.
- c.) Events conducted for the promotion of commercial products and/or services.

Examples of some events qualifying for commercial rates include:

- a.) Events organized by a for-profit group that promotes the entities products or services.
- b.) Events organized by private organizations where an entrance fee is required to participate.
- c.) Events open to the public that are widely promoted via social media or other marketing avenues.
- d.) Events open to the public such as fundraisers or athletic events with registration organized by any private businesses, individuals, civic groups or non-profit

Exempt from License Fees: Use of facilities and grounds SHALL be exempt from all facility license fees for the following, but SHALL be responsible for all costs associated with key deposits, utilities, paper products, and maintenance staff time during scheduled events:

- Langlade County Fair Board when properly scheduled for Langlade County Fair Activities. This exemption results from long time use of the facilities and grounds and long-term investments of County Fair funding for improvements in the Fairgrounds facilities.
- Antigo Area Hockey Association based upon annual scheduling. This exemption results from long time use of the facilities and grounds and long-term investments of association funding for improvements in the Fairgrounds facilities.
- Local 4-H Leaders Association, Langlade County Youth Groups, Langlade County Sponsored Events and Langlade County Local Governments; including Technical College and School Districts. This exemption results from the benefits provided to the residents and youth of Langlade County from these organizations are EXEMPT from any license fees.

EXCEPTIONS TO RENTAL FEE POLICY FOR LOCAL NON-PROFIT AND CHARITABLE GROUPS

Non-profit and charitable groups who rent park facilities for their activities shall pay the standard facility rental fees. Setup fees for tables and chairs in the Multi-Purpose Buildings can be waived if the renter sets up, takes down and properly stores the tables and chairs needed for their event. 'Local non-profit and charitable groups' include those groups who are based in Langlade County whose events benefit the citizens of Langlade County beyond their own members, affiliates and associates.
