3. Recite the Pledge of Allegiance and Please silence all cell phones.
4. **Approve/amend the minutes:** Motion by Curler, second by McGee to approve the March 9, 2023 meeting minutes. All ayes, motion carried.
5. **Brief introductions:** All present introduced themselves and stated their connection to the Unit Meeting.
6. **Legislator Reports:** Landis Holdorf, Congressman Tiffany's Office, discussed the activities of Congressman Tiffany.
7. **Update on LC Broadband Commission:** Angie Close, Economic Development Director, provided updates on the County Broadband Projects: Elcho Kent Tower (completed); Village of White Lake Project update; Town of Polar, Norwood and Rolling Broadband Project (will be started in 2023); Towns of Summit, Peck and Vilas (Grant just awarded). Close discussed the BEAD Planning Grant Award.
8. **YMCA Taskforce Update:** Angie Close, Economic Development, discussed the proposed YMCA Project, as the partners are now working with the School Board and the Boys and Girls Club.
9. **Langlade County Zoning Administrator Haakenson:** Haakenson distributed a copy of Flood Plain Maps and Zoning Updates. Haakenson discussed the proposed FEMA and DNR Flood Plain Maps, based on lidar, as the existing maps are from the 1970's. Haakenson stated every Community will need an adopted Flood Plain Ordinance and Map within 2-3 years, per the DNR and FEMA.

Zoning Update: Haakenson provided on the handout, the history and background of County Zoning; a listing of the Zoned Towns and the Un-zoned Towns that only have Shoreland Zoning within 1000 feet of a lake or 300

feet of a stream. Haakenson then explained the common Zoning Districts, permitted uses and conditional uses, and the process to change the Zoning designation of their land.

10. **Discussion Town Road and Funding from the State:** Board Chairman Pierce discussed the road conditions, deterioration due to many uses of the County Roads, looking to Lobby the State to get funding for local road repair. Willson noted that there is a bill in Madison regarding road repair dollars.
