2. **Approve minutes from last meeting.** Motion by Bonacci to approve the November 15, 2018 meeting minutes with a wording change to Item #5 A. it should state "The town can reduce the speed limit to 45miles per hour without special approval". All ayes, motion carried.

 - A. **Fatalities in Langlade County:**

 - C. **Speed Board for the year.** Brugman updated the Committee on the Speed Board usage. Stating an email has been sent to the Counties to create a list for all interested in the use of the speed board. Braun will be the main contact person for Langlade County in regard to the speed board signs. Information only.
